# **Seventh Grade Curriculum Map: Language Arts (p. 1)**

#### 1st Nine Weeks

Topics: Key Ideas and Details (Reading Literature – RL); Text Types and Purposes (Writing – W)

- 7.RL.1 cite several pieces of textual evidence to support analysis of what the text says explicitly as well as inferences drawn from the text.
- 7.RL.2 Determine a theme or central idea of a text and analyze its development over the course of the text; provide an objective summary of the text.
- 7.W.3 Write narratives to develop real or imagined experiences or events using effective techniques, relevant descriptive details, and well-structured event sequences.
  - a. Engage and orient the reader by establishing a context and point of view and introducing a narrator and/or characters; organize an event sequence that unfolds naturally and logically.
  - b. Use narrative techniques, such as dialogue, pacing, and description, to develop experiences, events, and/or characters.
  - c. Use a variety of transition words, phrases, and clauses to convey sequence and signal shifts from one time frame or setting to another.
  - d. Use precise words and phrases, relevant descriptive details, and sensory language to capture the action and convey experiences and events.
  - e. Provide a conclusion that follows from and reflects on the narrated experiences or events.

#### 2nd Nine Weeks

Topic: Craft and Structure (Informational Text – RI); Text Types and Purposes (Writing – W); Comprehension and Collaboration (Speaking and Listening – SL); Vocabulary Acquisition and Use (Language – L)

- 7.RI.5 Analyze the structure an author uses to organize a text, including how the major sections contribute to the whole and to the development of the ideas.
- 7.RI.6 Determine an author's point of view or purpose in a text and analyze how the author distinguishes his or her position from that of others.
- 7.W.2 Write informative/explanatory texts to examine a topic and convey ideas, concepts, and information through the selection, organization, and analysis of relevant content.
  - a. Introduce a topic clearly, previewing what is to follow; organize ideas, concepts, and information, using strategies such as definition, classification, comparison/contrast, and cause/effect; include formatting (e.g., headings), graphics (e.g., charts, tables), and multimedia when useful to aiding comprehension.
  - b. Develop the topic with relevant facts, definitions, concrete details, quotations, or other information and examples.
  - c. Use appropriate transitions to create cohesion and clarify the relationships among ideas and concepts.
  - d. Use precise language and domain-specific vocabulary to inform about or explain the topic.
  - e. Establish and maintain a formal style.
  - f. Provide a concluding statement or section that follows from and supports the information or explanation presented.
- 7.W.6 Use technology, including the Internet, to produce and publish writing and link to and cite sources as well as to interact and collaborate with others, including linking to and citing sources.

### 2<sup>nd</sup> Nine Weeks Continued

# Topics: Key Ideas and Details (Reading Literature – RL) and (Informational Text – RI); Text Types and Purposes (Writing – W); Conventions of Standard English (Language – L)

- 7.RL.3 Analyze how particular elements of a story or drama interact (e.g., how setting shapes the characters or plot.
- 7.RL.6 Analyze how an author develops and contrasts points of view of different characters or narrators in a text.
- 7.RL.7 Compare and contrast a written story, drama, or poem to its audio, filmed, staged, or multimedia version, analyzing the effects of techniques unique to each medium (e.g., lighting, sound, color, or camera focus and angles in a film).
- 7.RL.9 Compare and contrast a fictional portrayal of a time, place, or character and a historical account of the same period as a means of understanding how authors of fiction use or alter history.

## 3<sup>rd</sup> Nine Weeks Continued

  - b. Support claim(s) with logical reasoning and relevant evidence, using accurate, credible sources and demonstrating an understanding of the topic or text.
  - c. Use words, phrases, and clauses to create cohesion and clarify the relationships among claim(s), reasons, and evidence.
  - d. Establish and maintain a formal style.
  - e. Provide a concluding statement or section that follows from and supports the argument presented.
- 7.L.1 Demonstrate command of the conventions of standard English grammar and usage when writing or speaking.
  - a. Explain the function of phrases and clauses in general and their function in a specific sentence.
  - b. Choose among simple, compound, complex, and compound-complex sentences to signal differing relationships among ideas.
  - c. Place phrases and clauses within a sentence, recognizing and correcting misplaced and dangling modifiers.

#### 4<sup>th</sup> Nine Weeks

Topics: Craft and Structure, Range of Reading and Level of Complexity (Reading Literature – RL); Craft and Structure, Integration of Knowledge and Ideas, Range of Reading and Level of Complexity (Informational Text – RI); Production and Distribution of Writing, Research to Build and Present Knowledge, Range or Writing (Writing – W); Comprehension and Collaboration (Speaking and Listening – SL); Conventions of Standard English, Knowledge of Language, Vocabulary Acquisition and Use (Language – L)

- 7.RL.4 Determine the meaning of words and phrases as they are used in a text, including figurative and connotative meanings; analyze the impact of rhymes and other repetitions of sound (alliteration) on a specific verse or stanza of a poem or section of a story or drama.
- 7.RL.5 Analyze how a drama's or poem's form or structure (e.g., soliloquy, sonnet) contributes to its meaning.
- 7.RL.10 By the end of the year, read and comprehend literature, including stories, dramas, and poems in the grades 6-8 text complexity band proficiently, with scaffolding as needed at the high end of the range.

#### 4<sup>th</sup> Nine Weeks Continued

  - d. Acknowledge new information expressed by others and, when warranted, modify their own views.

### 4<sup>th</sup> Nine Weeks Continued

  - a. Use a comma to separate coordinate adjectives (e.g., It was a fascinating, enjoyable movie but not He wore an old [,] green shirt).
  - b. Spell correctly.
- 7.L.3 Use knowledge of language and its conventions when writing, speaking, reading or listening; choose language that expresses ideas precisely and concisely, recognizing and eliminating wordiness and redundancy

  - a. Use Context (e.g., the overall meaning of a sentence or paragraph; a word's position or function in a sentence) as a clue to the meaning of a word or phrase.
